

Please follow these four steps to help you quickly and easily donate your Gift of Publicly Traded Securities to Sinai Health Foundation.

1. Complete the “Letter of Authorization from Donor to Broker” form (below), which will help your broker initiate the electronic transfer of securities. If you have any questions about completing the form, please call 416-305-1434 or e-mail carla.silva@sinaihealthfoundation.ca
2. Send the completed transfer form to your broker or investment advisor who will initiate, and be responsible for the transfer.
 - a. If donating a mutual fund, please ask your financial institution to complete a Power of Attorney to authorize the re-registration of mutual fund units being donated. Send the Power of Attorney document along with this donation form to Team.Kruzich@RichardsonWealth.com
3. Please notify the Foundation by emailing a copy of the completed form to the Foundation c/o Carla Silva at carla.silva@sinaihealthfoundation.ca. This will help us to ensure that the transfer is received by our broker and that we are able to issue your donation receipt and provide appropriate recognition for your generous donation.
4. You will be issued a donation receipt based on the closing price on the date when the shares are transferred to the Foundation’s account at our custodial agent, Richardson Wealth.
(Note: Shares are considered legally transferred only when delivery is confirmed by our custodial agent.) It is the Foundation’s policy that all shares be sold as soon as possible after they have been received.

Thank you for considering a gift of securities to the Sinai Health Foundation. Making a gift of publicly traded securities is a simple, easy process and a wonderful way to support the Sinai Health.
